The PhD in Law Programme

The PhD degree is a thesis-only research degree. A doctorate is normally carried out over a minimum of 3 years full-time or 6 years part-time. The degree is undertaken under supervision by senior academics, usually by a lead supervisor and a co-supervisor. PhD candidates must complete a sustained course of research at the University of Auckland, resulting in the production of a substantial original thesis that meets internationally recognised academic standards.

You will be part of a fully engaged PhD cohort of high quality PhD candidates from around the world who you will get to know and share ideas and research with. Stimulating and rewarding, a PhD at Auckland Law School provides an exciting opportunity to engage in independent, cutting-edge research.
