## 2024 applications for 2025 RDF research projects: Info session

The submission deadline for RDF applications is 2 September. More details and relevant forms are available on the Faculty <u>intranet</u>. The Faculty Research Committee and the Business School Research Services team are arranging an in-person information session on 24 July about this contestable round (details on timing and venue are below). The session will cover issues, such as respecting the submission guidelines, application procedures, crafting a credible application, and budget considerations. #### Inaugural Ngā Ara Whetū Innovation Scholar

Congratulations to <u>Dr Jagdeep Singh-Ladhar</u>, who has recently been appointed in this role that aims to support emerging leaders at the early stages of their careers and foster their engagement with <u>Ngā Ara Whetū</u>. The position is a collaborative initiative between Ngā Ara Whetū (one of seven University Research Centres) and the Business School. Jagdeep is a Lecturer in the Department of Commercial Law, and her research interests are rooted in sustainability (her PhD thesis was on water allocation). Recently, she authored a book on water allocation law and policy in New Zealand, drawing comparisons with Australia. Jagdeep has gained valuable experience working with the Ministry for the Environment on recent reforms to the Resource Management Act. We look forward to her engagement with Ngā Ara Whetū in the areas of policy impact and research communication.

## From the Mid-Career Researchers Taskforce

A few weeks ago, the MCR Taskforce organised an interactive session for MCRs on navigating work-life challenges. The panel (Dr Drew Franklin, Prof Ilan Oshri, Prof Maree Roche, and Prof Christine Woods) interacted with the participants by sharing their own experiences, insights, and strategies for achieving a healthy work-life balance. As this is a re-occurring theme in continuous conversations, the MCR Taskforce has also co-organised with the Department of ISOM and the Early Career Researchers Committee an interactive session with <u>Prof Allen C Johnston</u> (University of Alabama) on work-life balance challenges and strategies for development and cultivation of networks. This will take place in September (details below). Our MCR writing retreat will be going ahead, as planned, in August. And Cohort 2 in the MCR Development Programme (one seat is still available) kicks-off its work in September.

#### **Research Ethics survey**

This UoA <u>survey</u> is open until 17 July 2024. Our feedback is requested to understand how the ethics journeys can be improved in regard to research ethics information, systems, processes, and training. The survey is short and anonymous and includes multiple-choice questions with optional comments. Doctoral and relevant masters students involved in ethics applications in the past 3-4 years are also welcome to participate. The insights and results will be shared in Q3 2024.

#### **Summer Research Scholarships**

The Faculty Research Committee approved 24 applications for Summer Scholarships projects. The projects opened for student applications from 1 July. All information about the faculty <u>projects</u> and how students can apply is available <u>here</u>.

#### **Social Sciences Research Network**

The <u>University of Auckland Business School SSRN Research Paper Series</u> subscription has been renewed for three years with the added benefit of a data analytics dashboard and the removal of the cap on numbers of work/abstract/paper uploads and

issues of eJournals. SSRN has also created a <u>new submission URL</u> portal that promises to be more agile in case you like to submit your own work. If you prefer, the submission can still be done for you by <u>Cicy Xiaoxi Zhu</u> who assists Assoc Prof <u>William Cheung</u> with SSRN-related matters. You may want to consult the <u>submission quick guide</u>. If you use the X app, you will soon start seeing UABS papers promoted by SSRN to increase their visibility.

## **Global Research Engagement Fund**

In ADR Update #4 (sent out 7 May) I wrote about the launch of the <u>Global Research Engagement Fund (GREF)</u>. As this is relatively new and might have escaped from colleagues' radar, here is the information again:

This new internal funding initiative seeks to support our engagement in major global research programmes and strengthen strategic research partnerships with international collaborators. Two separate award categories are available:

<u>Networking & Engagement Grants</u> (up to \$10,000): They will be used to establish and develop connections with external partners aligned with strategic international funding initiatives. The aim is to support attending in-person events/meetings considered essential to assist our international research activities whilst also increasing the University visibility amongst international stakeholders.

Project Planning Grants: These grants are available to individual researchers or research teams to support the preparation of proposals for large-scale, strategic international research funding initiatives. Eligible activities might include external workshop facilitation, participation in subject-relevant events to identify potential collaborators, procurement of external bid development support, or hosting proposal writing workshops with visiting collaborators. Two grant levels are offered based on the University's level of involvement in the resulting funding application: up to \$12,000 for participating on a project partner; up to \$25,000 for participating as a project lead.

Beneficiaries must be working towards a pre-identified partnership or funding opportunity that is clearly detailed in their funding application. Funding will be allocated across four cut-off dates this year, the next of which will be 27 September and 29 November.
